Following are equipment, services, and supplies that were discussed as candidates for solicitation, but deemed more appropriate for procurement using non-competitive means or competed using market pricing. The item is either readily available commercially, available from the cache, or not used often enough to warrant competition. The gamut of procurement tools are available to buy or rent necessary items: credit cards, BPAs, EERAs, etc. This does not preclude competition, however, if a unit so chooses. If your Geographic Area uses large quantities of these items, it may be beneficial to solicit for them.

Equipment Category	Justification
Air Conditioners	These are of a low dollar value that doing a solicitation would not justify the potential savings. These can be combined on a solicitation with tents.
Ambulance	Most ambulances are obtained through cooperative agreements with county or rural VFDs.
All Terrain Vehicles - 4-Wheel, 6-Wheel	These are commercially available. Competition is set in the marketplace.
Backhoe	A commercial item that is used minimally and typically for short duration (project specific) on incidents (Ref. CETG meeting notes 1/08)
Boat	These are used infrequently and not used by all Regions. It would not justify the cost of a solicitation.
Briefing Area Package	A commercial item that is used infrequently and would not justify the cost of a solicitation.
Bus, Coach	No special specs are needed. They are available in the commercial marketplace. They are mainly used for one way transportation and not needed to stay with crews. Commercial rates are available.
Bus, Shuttle	These are not used by all Regions. If your region utilizes this resource, solicit them.
Chainsaw	These are used by fallers that are hired as ADs. Not logical to do competition as a separate piece of equipment. These are also part of the faller module.
Chainsaw Repair Unit/Small Engine Repair	Not many units available. May not see cost savings if done in a solicitation. Optional for preseason agreement.
Chair, folding	Chairs are available in the cache or can often be purchased cheaper than rented. It will probably cost more to do a solicitation for chairs than the savings realized.
Chipper	Small chippers are commercially available. Larger chippers are not frequently used. Negotiate rental at time of incident.
Computer	Incident based Automation Group is looking at this item. They may want to do on a national contract as there are only a few known sources with the volume of laptops and printers that are needed. Currently R5 has EERAs.
Copier	Copiers are commercially available and sources are limited in small towns. Use commercial pricing.
Crew, Camp	Job Corps students and Tribal crews are utilized as camp crews whenever possible. Otherwise, local people are hired as an AD.
Crew, Strike Team	R6 is the only region that utilizes this resource. Encourage competition within R6.
Crew, Suppression Type II	Crews can be obtained on the national contracts. R6 is the only region that does a joint solicitation for this resource.
Engine Strike Team	R6 is the only region that utilizes this resource. Encourage competition within R6.
Fax Machine	Fax machines are available for rent from the same source as the copiers. It is often cheaper to purchase than to rent.
Feller Buncher	These are used infrequently and not used by all Regions. Negotiate at time of use or preseason. (Ref. CETG meeting notes 1/08)
Forklift	These items are commercially available and of low dollar value. The anticipated savings would not justify the cost of doing a solicitation.
Forwarder	These are used infrequently and not used by all Regions. Negotiate at time of use or preseason. (Ref. CETG meeting notes 1/08)
Front End Loader	These items are commercially available and used infrequently so would not justify the cost of doing a solicitation.
Generator	These could be combined on a solicitation with tents, a/c, and heaters. It would not be cost effective to do a solicitation for this item only.
Golf Cart	This item is commercially available and of low dollar value. The anticipated savings would not justify the cost of doing a solicitation.

Equipment Category	Justification
Hazmat Unit	This item is used infrequently and would not justify the cost of a solicitation. They are commercially available if needed.
Heater	These could be combined on a solicitation with tents and a/c. It would not be cost effective to do a solicitation for this item only.
Lighting	These items are commercially available and of low dollar value. The anticipated savings would not justify the cost of doing a solicitation but can be combined with tents.
Lowboy, Including Trailers	These will be competed with the equipment they haul.
Masticator (includes slashbuster)	These are used infrequently and not used by all Regions. Negotiate at time of use or preseason.
Office, Modular	These items are commercially available and can be procured using a credit card.
Pack String	These items are used infrequently and would not justify the cost of a solicitation.
Pallet Jack	These are commercially available. It is often cheaper to purchase this than rent it.
Printer	The Incident Based Automation Group is looking at this item and it will be combined with computers.
Pump, Fire (portable)	These items are available in the cache so are not frequently rented.
Refuse Collection	This is often regulated and only has one vendor in the area.
Road Grader	A commercial item that is used minimally and typically for short duration (project specific) on incidents (Ref. CETG meeting notes 1/08)
Satellite Kit	The Incident Based Automation Group is looking at these and possibly doing a national contract.
Satellite Phone	The Incident Based Automation Group is looking at these and possibly doing a national contract.
Skidder	These are used infrequently and not used by all Regions. Negotiate at time of use or preseason. (Ref. CETG meeting notes 1/08)
Sleeper Unit, Mobile	Only a couple of regions use these so they could be competed by those regions.
Spill Kit	This item is available in the cache system. If not available, procure commercially.
Table	These are available in the cache. It is often cheaper to purchase tables rather than rent them and not cost effective to issue a solicitation.
Tank, Portable (Water Storage)	Small ones are available in the cache. If not, procure locally.
Tractor, Plow	This item is only used in a couple regions and it would not be beneficial to compete on a national level. It can be combined with the heavy equipment solicitation.
Tractor, Truck	These are usually used for cache vans. Some caches already have contracts for this service. It can be procured commercially and locally.
Traffic Control Equipment	Some regions have a cache of this. If not, it can be obtained from local road departments or rented commercially.
Trailer, Cargo	This item is used infrequently and would not justify the cost of a solicitation. They are commercially available if needed.
Trailer, Flatbed	This item is used infrequently and would not justify the cost of a solicitation. They are commercially available if needed.
Transportation, Stock	This item is used infrequently and would not justify the cost of a solicitation. They are commercially available if needed.
Truck, Crash Rescue	This item is very specialized and used infrequently. If needed, acquire through commercial means (or at-incident EERA).
Truck, Dump	commercially available if needed or can be combined with the heavy equipment solicitation.
Van, Box	Low quantities of this are used and it can be procured commercially.
Vehicle, Rental	Use the GSA contract that allows use off-road.
Vehicle, w/driver	This item is a low dollar item and the anticipated cost savings would not justify the cost of issuing a solicitation; however, lining up these resources preseason is recommended and use of national template is required.

These equipment categories require further action to be facilitated by the FESSAA Team.

Equipment Category	Notes
Bus, Crew Carrier	Regional responsibility unless a national contract is decided. Proposal conveyed to FAM Dec 2006; Decision to keep as regional resource March 2008.
Caterer, Mobile	Look at present national contracts - can they be modified to include all incidents? Can small caterers be included? Need to assess numbers of small caterers presently being signed up by local units before FAM can make a request to AQM.
Computer & Printers	The Incident Based Automation Group is looking at computers and accessories (printers)
Fuel Tender (non-aviation)	Follow-up on use of credit cards by vendors to alleviate tracking nightmare
Infra-Red Imager	FAM must identify a need to warrant a solicitation.
