

## Schedule of Forest Service Land Management Plan Revisions & New Plans

October 1, 2003

The Land Management Planning rule adopted November 9, 2000, required the Chief of the Forest Service to develop a Land Management Plan (LMP) Revision Schedule for the National Forest System (NFS) units that had not completed revisions of their plans. Accordingly, the LMP Revision Schedule was published in the Federal Register November 30, 2001 (66 FR 59775). As indicated in the Federal Register notice, the Revision Schedule will be updated as needed to account for new information and changed conditions. To keep the public informed of the revision schedule, schedule changes will be posted on the Forest Service Ecosystem Management Coordination staff website.

Since the publication of the November 2001 schedule, a number of NFS units have had to adjust the timeframe for their plan revisions. The following four tables display the updated Service-wide Revision Schedule for each unit of NFS by fiscal year as well as the schedule for the development of new plans for recently established units of NFS. Table 1 lists plan revisions completed to date. Table 2 lists plan revisions already underway. Table 3 lists anticipated start dates for upcoming plan revisions. Table 4 displays the schedule for development of new plans for two recently established units of NFS, the Midewin National Tallgrass Prairie and the Land-Between-the-Lakes National Recreation Area.

Posting of this schedule does not constitute an initiation of a plan development or revision process for any NFS unit. A Notice of Intent to develop or revise a plan, which is published in the Federal Register as well as in newspapers of general circulation within the area covered by the plan, initiates the revision process for each plan. Additionally, this posting of the schedule on the Forest Service Ecosystem Management Coordination staff website does not, in itself, constitute an action subject to the National Environmental Policy Act procedures of 40 CFR parts 1500 – 1508 or Forest Service Handbook 1909.15. The Service-wide Revision Schedule will continue to be adjusted as necessary and, at regular intervals, posted on the Forest Service Ecosystem Management Coordination staff website at [www.fs.fed.us/emc/nfma](http://www.fs.fed.us/emc/nfma).
