Subject: Waiver of the Biweekly Maximum Earning Limitation in Response to the Deepwater Horizon in the Gulf of Mexico - Extended Through December 4, 2010

To: Tom Harbour, Director, Fire and Aviation Management

Enclosed is the USDA, Office of Human Resources Management's approval memorandum, "U.S. Department of Agriculture (USDA) - Wide Bi-weekly Pay Cap Waiver", extending the waiver of the biweekly maximum earnings limitation through December 4, 2010 (pay period 24), in which Forest Service employees are required to work considerable amounts of overtime in response to the Deepwater Horizon oil spill in the Gulf of Mexico. The catastrophic explosion which caused an oil spill from an offshore drilling rig in the Gulf of Mexico began on April 20, 2010.

Those employees who are exempt from the biweekly maximum and from the Fair Labor Standards Act (FLSA) must be reminded that they are subject to the annual maximum earnings limitation and it is up to each employee to assure that they do not earn more premium pay than the law allows per year.

The employee's annual maximum earnings limitation for calendar year 2010 is the greater of the salary for Level V of the Executive Schedule (or \$145,700.00) or the GS-15, Step 10, rate of pay, including any applicable locality payment or special rate supplement they receive.

For your convenience, we have enclosed the 2010 annual caps on premium pay for each of the locality areas. As the attached enclosure reflects, the annual caps listed for each locality area are higher in every case than the salary for Executive Schedule Level V.
