

Fire Shelter Re-Bagging Offer

Freedom Packaging Company Inc. Amsterdam, New York

Is the only company approved by the U.S. Forest Service to re-bag fire shelters.

If your organization uses the fire shelters pictured above on the left, your personnel may be in danger of not being able to open the fire shelter bag in a fire emergency. It has been proven that many of the old style rings are defective and may rip off leaving your personnel with no easy method of opening the bag to access the fire shelter.

Freedom Packaging Company (FPC) for the past several years has successfully re-bagged tens of thousands of fire shelters for the U.S. Forest Service and private contractors. FPC is extending its re-bagging service to all organizations that use these fire shelters. FPC will removed your shelter from the old vinyl bag and resealed into a new U.S. Forest Service approved bag including a web strap with Velcro™. A newly re-bagged shelter is pictured above on the right.

FPC will execute a production run for re-bagging fire shelters when we have a commitment of 500 shelters or more. Please reply to email address: fireshelter@nycap.rr.com with the number of fires shelters you will commit for re-bagging. When we have a commitment that totals 500 or more we will email each re-bagging customer to ship the shelters to our factory. All shelters must be received by FPC within 2 weeks of notification. All shelters will be re-bagged and returned expeditiously. Your organization will be responsible for the cost of transporting the fire shelters to and from FPC.

In order to participate in the program please follow these directions carefully:

1. Email fireshelter@nycap.rr.com with the number of shelters you will commit for re-bagging
2. Agree to pricing which is:
 - a. 1 to 10 shelters - \$ 16.00/per re-bagged shelter
 - b. 11 to 25 shelters - \$ 14.00/per re-bagged shelter

c. 26 or more - \$ 12.00/per re-bagged shelter

3. AFTER email notification that FPC has secured commitment of 500 shelters to re-bag, send shelters within 14 days to:

4. Acceptable payment will be MasterCard or VISA charged on the date of return shipment. Return shipping costs will be added to the total. (If you are unable to pay using a credit card

Please contact FPC at 518 842 5109 EX 42 to set up an account and agree to payment terms.

5. Complete and copy the re-bagging order form. Fax one copy to FPC at 518 842 6501 and enclose a second copy with your shelters.

6. Remove shelters from hard plastic case and only return the shelters in the old vinyl bag. (Save the hard plastic cases at your facility.)

7. Be sure that your shipping boxes are sturdy enough to safely transport the shelters. Tape both tops and bottoms of the boxes.

8. Number all boxes 1 of 3, 2 of 3, 3 of 3..... etc

9. Counting of the shelters must be accurate. Any discrepancies between the order form and actual count will delay the re-bagging of your order until the correct count is confirmed.

Freedom Packaging Company is committed to providing your personnel a failure proof fire shelter bag that opens quickly and completely.
