**EMERGENCY ORDER  
NATIONAL FOREST SYSTEM ROADS**

Ten Mile Drainage  
Helena Ranger District

Pursuant to Title 36 code of Federal Regulations 261.50 (a&b) the following restrictions are in the Helena National Forest. These restrictions are in addition to those enumerated in Subpart A, part 261, Title 36, Code of Federal Regulations, and become effective July 10,2006, and will remain in effect for one year or until rescinded.

**36 CFR 261.54 – National Forest System Roads**

**Using any type of vehicle prohibited by the order. [Title 36, 251.54 (a)]**

For the purpose of this order it is prohibited to operate a motor vehicle during operating hours, which are Monday through Friday 7 a.m. to 8 p.m. on Helena National Forest System roads as listed in Attachment "A" hereby made part of this order.


**Definitions: Vehicles (including cars, trucks, all-terrain vehicles which include 3-wheelers, 4-wheelers, 6-wheelers, and motorcycles) means any device in upon or by which any person or property may be transported, including any frame, chassis, or body of any motor vehicle.**

**Exemptions:**

**Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:**

1. Any person with a permit authorizing an otherwise prohibited act or omission.
2. Any federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of official duty.

**Penalty:**

Violations of these Prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both [ 16 U.S.C. 551, and 18 U.S.C. 3559 and 3571]
