PUBLIC NOTICE OF REALTY ACTION
Fir & 8th Street Administrative Site
Elko, Nevada

Notice is hereby given that the Forest Service, United States Department of Agriculture, is proposing to sell the lands identified below at not less than the market value pursuant to the Forest Service Facility Realignment and Enhancement Act of 2005, as contained within Title V of Public Law 109-54.

The proposal for sale includes the following lands and interest in lands under the jurisdiction of the Forest Service:

Humboldt-Toiyabe National Forest
Elko County, State of Nevada

Mount Diablo Meridian
T. 34 N., R. 55 E.
Section 15

Lots 18-23, and westerly 5' of Lot 24 of Block 91 of the First Addition to City of Elko, Nevada, including adjacent 10' wide vacated alley, County of Elko, State of Nevada. Containing .394 acres, more or less.

Lots 2, 3, 4, and the Westerly 5 feet of Lot 1 of Block 69 of the First Addition to the City of Elko, County of Elko, State of Nevada. Containing .184 acres, more or less.

The property consists two sites separated by Fir Street, located in two separate blocks within the City of Elko. Improvements located on the lots within Block 91 include a warehouse, a storage shed, a residence, and a tire storage shop/office. A portable wood barn structure is also present. Improvements on the lots within Block 69 include a warehouse and a carpentry shop. The mineral estate will be included in the estate to be sold.

The property may be sold directly to an identified purchaser or may be sold under competitive bidding procedures. The method of sale will be determined at a later date. The sale will be subject to valid existing rights and encumbrances of record. The Forest Service may also include in the conveyance any reservation necessary to protect the interests of the United States. Specific terms of the sale will be provided in an Offer to Sell which will be made after all environmental studies and other required analysis are completed and final decision to sell the property is made.

Federal law requires purchasers to be U.S. citizens, 18 years of age or older; a corporation subject to the laws of any State or of the United States; a State, State instrumentality, or political

subdivision authorized to hold property; or an entity, including but not limited to associations, partnerships, capable of holding property in the State. Proof of qualification to purchase the property will be required.
