Dear Interested Party:

The Cleveland National Forest is seeking public comment on an environmental assessment (EA) dealing with motorized travel management. Activities proposed and analyzed in the EA include changes to the Cleveland National Forest transportation system by adding roads for highway-legal vehicles only; adding trails for ATVs and motorcycles; and revising the size of the Corral Canyon and Wildomar OHV open areas.

These activities are proposed in order to implement the 2005 Travel Management Rule (36 CFR 261) while still providing for a diversity of motorized vehicle recreation and for motorized access to dispersed recreation locations. The EA discloses environmental impacts associated with a no action alternative, the proposed action that was released for scoping in January 2008, and an alternative that was developed using comments submitted by the public during the scoping period.

Comments on the EA must be submitted within 30 days after the date the legal notice announcing the availability of the EA for comment is published in the San Diego *Union-Tribune*. The publication date is projected for July 15, 2008.
