- ◆ **No Reservations.** Sites are available on a first-come, first-served basis.
- ◆ The campgrounds are owned and operated by P.G. & E.

- ◆ The campgrounds are available for use after the Blue Lakes Road is opened by Alpine County. The exact date is dependent on the snowfall.
- ◆ The campground is at about 8,200' elevation.
- ◆ There is an additional charge for extra vehicles/R.V.'s parked in camp units
- ◆ There is an additional charge for dogs.
- ◆ Please keep family pets on a leash at all times.
- ◆ Please use the stove or fire ring provided.
- ◆ Use only dead and down wood for your campfires.
- ◆ Make sure your fire is dead out before leaving.
- ◆ Check out time is 1:00 p.m.
