USDA Forest Service Pacific Southwest Region



The Eldorado National Forest does not allow Christmas tree cutting.

National Forests that allow Christmas Tree Cutting:

Lake Tahoe Basin Management Unit - (530) 543-2600

Permit is \$10 (2 permits/family); pine, fir, or cedar. Permit sold at the LTBMU Supervisor's Office at 35 College Drive, South Lake Tahoe, beginning November 24, Monday through Saturday 8:00 am to 4:30 pm until the permit supply is exhausted.

Humboldt - Toiyabe National Forest - (760) 932-7070 (Bridgeport Ranger District, Bridgeport)

Permit is \$5.00; pinyon pine or white fir. Permits available at Bridgeport Ranger District in person or by mail. Also available at Mono Lake Visitor Center, Mammoth Ranger District, White Mountain Ranger District and the Supervisor's Office in Sparks (775) 331-6444 or (775) 355-5302 in person. Check locally for office hours. Monday through Friday 8:00 a.m. to 4:30 p.m. Closed Holidays.

Klamath National Forest - (530) 842-6131 (Supervisor's Office, Yreka)

Permit is \$10.00 per permit; limit one tree per household. A maximum of 5 permits may be purchased for separate families. Permits issued in person or mail-in to Supervisor's Office. Check Ranger Districts for hours.

Lassen National Forest - (530) 257-2151 (Supervisor's Office, Susanville)

Permit is \$10.00 per permit, limit two trees per household. Permits available at Ranger Districts November 1 through December 12. Old Station Visitor Center will be open Saturday through Sunday, 9:30 a.m. to 4:00 p.m. through December 14. Call for specific district days and hours.

Mendocino National Forest - (530) 934-3316 (Supervisor's Office, Willows)

Permit is \$10.00; one tree, mail-ins, selling permits weekdays from 11/17 through 12/19 at all ranger districts. Covelo Ranger District: Saturday and Sunday December 6, 7, 13, and 14, 8:00-2:00 only. Stonyford Ranger Station open Saturdays 8:00 a.m. - 4:30 p.m. (530) 963-3128. Upper Lake Ranger Station open Saturdays on the first two weekends in December from 8:00 a.m. - 4:30 p.m. (707) 275-2361.

Modoc National Forest - (530) 233-5811 (Supervisor's Office, Alturas)

Permit is \$10.00 for each permit (two trees) at the Modoc National Forest headquarters, weekdays in Alturas and District offices in Adin, Cedarville and Tule Lake. Two permits per household. Permits available for 11/17 to 12/24.

Plumas National Forest - (530) 283-2050 (Supervisor's Office, Quincy)

Permit is \$10.00 (One tree); limit two trees per household; mail-ins by December 1 for all designated areas in the forest. Beckwourth, Feather River and Mt. Hough Ranger Districts sell in person, open 8:00-4:30 Monday through Friday. Additionally, permits may be purchased at the Greenville Information and Work Center during the week (530) 284-7126. Call for current information.

Shasta Trinity National Forest - (530) 226-2500 (Supervisor's Office, Redding)

Permit is \$10.00; limit one tree per household. A maximum of 5 permits may be purchased. Permits sold 11/03 through 12/24. Mail-in requests to the Supervisor's Office, allow 7-10 days. Ranger Districts sell in person. Call for days and hours.

Six Rivers National Forest - (707) 442-1721 (Supervisor's Office, Eureka)

Permit is \$10.00; limit one tree per household. All Ranger Districts sell permits; check locally for hours. Permits available all year and expire on 12/26. Monday through Friday 8:00 a.m. to 4:30 p.m.

Local Christmas Tree Farms

The Eldorado National Forest does not issue Christmas tree permits since there are over 30 local Christmas Tree farms in the area. Many of these also provide food, crafts, activities, and a chance to visit with Santa Claus.
