



MAP LAYER LEGEND	
MAP LAYERS	DESCRIPTION OF THE LAYER
Analysis Unit Boundary	Displays the dark gray outline boundary of all 10 analysis units.
Analysis Unit Label	Displays the labeling of the 10 analysis units.
Analysis Unit Legend Map	Displays the analysis unit maps on the legend.
Background	This layer can show up multiple times on the legend and displays the gray background and the gray inset background on the map.
Background Feature	Displays the campsites, trailheads, streams, forest boundary, wilderness, major reservoir, land status.
Combined Use Roads	Displays the highway legal roads, allowing non-highway legal use.
Existing System No changes	Displays no changes to the existing system.
Labels	Shows up multiple times and displays the following areas: Wilderness label, motorized use areas label, legend analysis unit label, highway symbols.
Motorized Use Areas	Displays the motorized use areas marker.
Other	There can be more than one " <i>Other</i> " layer followed by a number after it. Other displays several things including gray background, legend items, inset window, inset outline, north arrow, scale bar, table, and map border grid.
Private, Commercial, Federal, or Special Uses Roads	Displays other public and private roads not part of this process.
Public Roads (State,County,City)	Displays public roads not managed by the Forest Service and not part of this process.
Quarter Quad Grid	Displays a grid referencing the whole Forest by quarter quad.
USGS Quarter Quad Name Label	Displays the names of the old USGS quarter quad labeling system using common area names.
USGS Quarter Quad Number Label	Displays the names of the new USGS quarter quad labeling system.
Roads Existing Changes	Displays the changes to the existing roads system.
Roads Label	Displays the road numbers with season-of-use indicator.
Roads Leader Line	Displays the lines referencing to the roads label.
Routes	Displays the unauthorized routes added to the system.
Routes Label	Displays the route number with season-of-use indicator.
Routes Leader Line	Displays the lines referencing to routes label.
Trails Existing Changes	Displays the changes to the existing trail system.
Vicinity Map	Displays the Vicinity Map of the Sierra National Forest on the legend.
