Water and Garbage: These services are provided at some campgrounds Memorial Day through Labor Day.



Weather: The weather in this area is unpredictable and changes greatly with elevation. We suggest that you check the weather forecast before you start your trip.



Clean Camp: Wildlife are attracted to a variety of odors (food, garbage, cosmetics, ect.). Keep a clean camp. Store food and garbage properly at all times. Store food in your car trunk if available. Otherwise, place food in a bag, backpack, or pannier and hang from a tree branch at least 15 feet above ground and 4 feet from the tree trunk. DO NOT STORE ITEMS IN TENTS.



Firewood: Campers may use up to ¼ cord of firewood, per day, for each campsite without needing to get a firewood load stub. Removal of firewood IN a campground is not allowed. Unused firewood must be left in the campground when you leave. See Okanogan National Forest Firewood Removal Guide Map (FREE) for more information.



Reservations: Campgrounds are on a first come first serve basis.



Fees: Fees for campgrounds must be paid within ½ hour after arriving.

Most importantly, always bring along a healthy dose of common sense. Safety is

the most important factor to insure an enjoyable outing.

Continue on forest road #32 past Bonaparte Lake Campground for an additional 3 miles to a fork in the road. Turn left on forest road #33 N for 5 miles to a four corner junction, turn left on forest road #3200-050 for 1/4 mile to the campground. | 18 | 13 | Yes Flush and Vault. | Beaver Lake | 2,700 | From Tonasket take State Highway 20 E for 20 miles to Bonaparte Recreation Area exit. Go 6 miles N on Okanogan County road #4953 which turns into forest road #32. Continue on forest road #32 past Bonaparte Lake Campground for an additional 3 miles to a fork in the road. Turn right on forest road #32 E for 3 miles, that drops in elevation to the campground. | 11 | | Yes Vault | Yes Hand Pump | Yes | \$6 | Boating, fishing, and access to Beth Lake trail #316. Group campsites available. |
| Beth Lake | 2,800 | From Tonasket take State Highway 20 E for 20 miles to Bonaparte Recreation Area exit. Go 6 miles N on Okanogan County road #4953 which turns into forest road #32. Continue on forest road #32 past Bonaparte Lake Campground for an additional 3 miles to a fork in the road. Turn right on forest road #32 E for 3 miles, that drops in elevation to the Beaver Lake campground. | Lyman Lake | 2,900 | From Tonasket take State Highway 20 E for 13 miles and turn right on Okanogan County road #9455 (Aeneas Valley road) heading SE for 13 miles to Okanogan County road #3785. Turn right and go 2 miles S to forest road #3000-500, that takes a sharp right turn and with another right turn on forest road #3000-580 which leads to the campground. | 4 | | Yes Vault | No | No | No | Fishing |
| Crawfish Lake | 4,500 | Off State Highway 97, go through the town of Riverside crossing the Okanogan River on Okanogan County road #9320 and travel E for 18 miles (this road changes from paved to gravel road). | Long Swamp | 5,500 | From Tonasket take State Highway 7 (also known as Okanogan County road #9437) cross the Okanogan River and go N for 6 miles. The road then turns W and turns into Okanogan County road #9425. Take Okanogan County road #9425 for 13 which goes through the town of Loomis. Turn W on Okanogan County road #4066, which turns into forest road #39 (Toats Coulee road) continue for 20 miles to campground. The campground is just S of the junction of forest road #39 and forest road 3900-300. | 3 | | Yes Vault | No | No | NWFP | Trailhead, hiking/horse trails and stream.
