14. DESCRIPTION OF AMENDMENT/MODIFICATION *(Organized by UCF section headings, including solicitation/contract subject matter where feasible.*

During the negotiation process it was discovered that the minimum performance requirements – Type III, Standard Helicopters was overstated for the areas we normally operate at. The purpose of this amendment, as discussed with vendors by telephone on June 25, 2002, is to change the minimum performance requirements as stated in Section B, page 4. The minimum performance requirement was overstated for the areas we normally operate at in Oregon and Washington. It was determined that the minimum performance requirement be that the helicopter(s) have the capability of hovering-out-of-ground (HOGE) at **5,000 feet** MSL and **30 degrees C** with a minimum **non-jettisonable payload of 550 pounds**. It was also determined that aircraft not meeting this requirement yet meeting all other contract requirements could be used for project work, subject to the fact that the aircraft performance meets project requirements.
