**14. Special Povisions:**

Payment shall not be made by Credit Card; Payments are to be made by Albuquerque Service Center.

The monthly rates listed apply for one month or any portion of one month. A 7-day grace period will be granted on returns after the first month rental. For example: if the renewal date is June 1 and the equipment is received on June 8, the equipment will not be renewed and the subsequent monthly rental will not be invoiced. If the equipment is received after the 7 day grace

period, the subsequent month will be invoiced in full for all the outstanding equipment. For example: if equipment due back on June 1 is received after June 8, it will be invoiced from June 1 for an additional month.

If equipment is moved from the site for which it was originally ordered and delivered, the Government will notify the contractor who the new point of contact will be and of the new location and phone number.

Incident Team/ Forest is responsible for the return shipping of all equipment.

No cancellation of order after equipment is shipped/leaves our office.



