9a. Project Cost: \$9,000

Conduct a survey of National Forest lands in Lincoln County, including past weed control projects, to help identify areas where additional control of noxious weed species is required. High priority areas would include high use recreational areas, areas along highways and county roads, buffer areas around Wilderness areas and key watersheds. Initial control actions using biological, manual or mechanical methods to control species based on "best effective tool" would be completed by Lincoln Co. Vegetation Management crews through a cooperative agreement. Implement measures to prevent the spread of weeds into new areas. Prioritize areas for weed control and complete NEPA planning where needed to implement Integrated weed control actions.
