#### **68.1 SOUTHERN AREA INCIDENT MANAGEMENT TEAMS**

Team on-call rotation is as follows:

1. The weekly rotation begins at 0001 hours every Wednesday and runs through 2400 hours the following Tuesday.
2. Once one team is assigned to an incident, the other team becomes on-call until the assigned team is released. If an assigned team is released during its scheduled on-call period, it will resume on-call status as soon as the team is available for assignment, and will serve the remainder of its scheduled rotation period, or until it receives an assignment.

### **69.6 NATIONAL PARK SERVICE ALL-RISK INCIDENT MANAGEMENT TEAM**

#### **69.6.1 EASTERN ALL-RISK TEAM**

The Southern Area has one NPS All-Risk Incident Management Team. The Team consists of eight team members and one trainee.

The Eastern Regions consist of the Northeast, National Capitol, Southeast Regions of the National Park Service.

To mobilize a team:

1. The request shall go to the Team Coordinator, Don Boucher, NCR Fire and Emergency Program Manager who will obtain approval from the Regional and Regional Coordinator.
2. The Team Coordinator will contact the available IC.
3. The IC will identify team members and communicate the Team Roster to the Team Coordinator.
4. The Regional Coordinator after receiving the names of the team members will relay the information to the Park or responsible dispatch office for processing the appropriate name requests through the dispatch channels.
