4. FIRST AID MEASURES

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

EYE PROTECTION: Where there is significant potential for eye contact, wear chemical goggles and have eye flushing equipment available.

2,4-pentandiol, 2-methyl- is an eye irritant; contact with liquid or mists may cause damage to the eyes which are reported to heal slowly. If ingested and absorbed, central nervous system (CNS) depression may occur as evidenced by giddiness, headache, and dizziness progressing to unconsciousness and death. Organ weight changes and effects on liver and kidney tissues have been reported in rodents in repeat dosing studies. No effects were seen on fertility of male rats following repeat oral dosing.
