



## Family Forest Ownerships with 10+ Acres in the Pacific Coast region\*, 2011-2013

The U.S. Forest Service, Forest Inventory and Analysis program conducts the National Woodland Owner Survey in order to better understand: who owns America's forests, why they own it, what they have done with it in the past, and what they intend to do with it in the future. This document summarizes data on family forest ownerships with 10+ acres in the Pacific Coast region. These summaries are based on responses from randomly selected landowners from across the Pacific Coast region collected between 2011 and 2013 (n=360). 


Figure 1.—Percentage of forest land in the Pacific Coast region\* by ownership category.<sup>2</sup>

- Area owned: 12,424,000 acres<sup>3</sup> (SE=318,000)
- Number of ownerships: 184,000 (SE=17,000)




Figure 3.—Size of forest holdings.




Figure 4.—Forest land is part of home or farm.




Figure 5.—Forest land tenure.




Figure 6.—Reasons for owning.<sup>4,5</sup>




Figure 9.—Activities in the *past* 5 years.<sup>5</sup>




Figure 7.—Landowner concerns.<sup>4</sup>




Figure 10.—Likely activities in the *next* 5 years.<sup>5</sup>




Figure 8.—Landowner age.




Figure 11.—Management activities.
